- (2) Costs and expenses of litigation recovered by any claimant from the Insured which are not incurred in and recoverable in the Stated Territory in the Schedule of the Policy.

#### Special Notes:

General Exceptions (for Public Liability)

- 1-Any liability, which attaches by virtue of an agreement but which would not have attached in the Absence of such agreement.
- 2-This insurance excludes loss, damage, cost or expense of whatsoever nature directly or indirectly caused by, resulting from or ir connection with any act of terrorism.
- 3-All Claims to be settled after a final court decision of an Egyptian court.
- 4-It is known and agreed, that this cover exclude the bodily injury (poisoning) to any third party person resulting from consuming the foods and beverages prepared and served by the insured in addition to the liability resulting from the consumption of canned and preserved food not known or prepared by the insured.
- 5- it is known and agreed, that this cover exclude the bodily injury resulting from the practice of any dioring and/or any kind of water sports activities.

6-This insurance excludes loss, damage, cost or expense of whatsoever nature directly or indirectly caused by animals safari.
